**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE WEST SLOPE WATER DISTRICT TO AMEND THE DISTRICT FEE SCHEDULE TO INCLUDE SYSTEM DEVELOPMENT CHARGES APPROVED BY THE BOARD WITH RESOLUTION #03-2019**

**WHEREAS**, the Board of Commissioners of the West Slope Water District voted on September 19, 2018 to amend the District fee schedule for after-hours service restoration following bill non-payment (Resolution #08-2018), and;

**WHEREAS**, the need for that fee adjustment was to cover the cost of service for after-hours tasks at the customer's request considering District labor, administrative, and vehicle use costs, and;


**WHEREAS**, the Board of Commissioners voted to increase the District's System Development Charges by a construction cost index by Resolution #03-2019 on February 20, 2019;

**BE IT RESOLVED:**


The Board of Commissions hereby amends the District's Fee Schedule table to reflect the District's revised customer fees (Resolution #08-2018) and the District's System Development Charges indexed for 2018 (Resolution #03-2019) by passage of this Resolution as presented in Exhibit A.

### OTHER SERVICE CHARGES AND PENALTIES

1. Turning on water by Water District personnel:
  - a. With an approved Turn On order from office staff during regular office hours No Charge
  - b. After office hours, weekends, and holidays No Charge
2. Special Service: Shut Off and/or Turn On at customer's/owner's request:
  - a. During regular office hours No Charge
  - b. After office hours, weekends, and holidays No Charge
3. Shutting Off and Turning On service for water non-payment:
  - a. During regular office hours \$100.00
4. Additional charges, if necessary, to enforce payment of a bill and/or charges:
  - a. Removal of the water meter \$25.00
  - b. Reinstallation of the meter No Charge
  - c. Turning on water after hours weekends or holidays \$200.00
  - d. Turning on and/or using water without authority from The District \$25.00
  - e. Installation or removal of a lock on a meter \$25.00
  - f. Repair of any breakage/damage to locking mechanism (curb stops, etc.) Parts & Labor + 15%
  - g. Shutting off water at the main or reinstating service Parts & Labor + 15%
  - h. Check returned by bank for non-payment (NSF) \$25.00
  - i. Electronic fund transfer (NSF) \$25.00
  - j. Replacing destroyed locks \$25.00
  - k. Notice of Shut Off placed on doorknob \$25.00
5. Decreasing or increasing the size of the meter Parts & Labor + 15%
6. Increasing the size of the service from the main New Service Charge
7. Testing water meters at the customer's or owner's request:
  - a. Testing on premises (1-inch or smaller) No Charge
  - b. Removal of meter for testing (1-inch or smaller) No Charge
  - c. Testing of meters larger than 1-inch No Charge
