**RESOLUTION NO. 03-2022**

**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE  
WEST SLOPE WATER DISTRICT ADJUSTING DISTRICT  
EMPLOYEE SALARY SCHEDULES**

**WHEREAS**, a regular meeting open to the public was held by the Board of Commissioners of the West Slope Water District on February 16, 2022 to discuss adjusting the District Employee Salary Schedules for Fiscal Year Ending June 30, 2023, effective July 1, 2022, and

**WHEREAS**, in accordance with the District's Adopted Budget Calendar for Fiscal Year Ending June 30, 2023; and

**WHEREAS**, based upon the General Manager's recommendations and testimony considered by the Board at the regular meeting, the Board of Commissioners finds that:

- (1) The District shall approve a cost-of-living adjustment to increase the Fiscal Year Ending June 30, 2023 District Employee Salary Schedule for seven (7) District positions equal to the change in the Official U.S. Dept. of Labor, Bureau of Labor Statistics, Consumer Price Index – All Urban Consumers (CPI-U), Pacific in the amount of 7.3%, as published January 2022, and
- (2) The cost-of-living adjustment approved by this Resolution shall be applied to District employee salaries effective July 1, 2022.


**BE IT RESOLVED:**

Section 1: The 2022-2023 Salary Schedule in Exhibit "A", attached hereto and by this reference shall be increased for each identified District position in the amount of 7.3%


Section 2: The General Manager has the authority and discretion to pay entry level employees 80-percent of the minimum salary schedule and employees with demonstrated skills and experience up to 10-percent over the maximum salary schedule with the approval by the Board of Commissioners.
