# A RESOLUTION ESTABLISHING RATES, FEES, AND OTHER CHANGES FOR THE WEST SLOPE WATER DISTRICT; DECLARING EFFECTIVE DATE; AND OTHER MATTERS RELATING THERETO

WHEREAS, a public hearing was held by the Board of Commissioners of the West Slope Water District ("District") on April 16, 2014 for the purpose of considering increases in the rates to be paid for the purchase of water from the District; and

WHEREAS, the Board of the District is authorized to set water rates and charges by resolution; and

WHEREAS, pursuant to the provisions of ORS 264.312, notice of said public hearing and the purpose thereof was given by mailing a notice of hearing to patrons of the District in accordance with the requirement of said statute; and

WHEREAS, based on the recommendations of the Administrative Staff of the District and the testimony heard, received and considered by the Board from such public hearing, the Board of Commissioners finds that:

- (1) The District purchases all of its water supply for distribution within the District from the City of Portland; and
- (2) The Board of Commissioners accepts and approves the recommendations of its Administrative Staff that the rates for water purchased should be adjusted in accordance with the staff written recommendation which is part of the record herein; and
- (3) It is necessary to adopt rates for water purchased from the District and related rates and charges in accordance with the Schedule of Rates set forth below in order to provide funds to cover cost of operating the District, and to meet debt obligations and responsibilities.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE WEST SLOPE WATER DISTRICT AS FOLLOWS:

Section 1: Effective November 1, 2014

The rates and charges shown in Exhibit "A" attached hereto and by this reference incorporated herein, shall be adopted by the District.
