**RESOLUTION NO. 02-2022**

**A RESOLUTION AMMENDING THE DISTRICT’S FEES FOR INSTALLING NEW SERVICE CONNECTIONS, INSTALLING NEW METERS, AND INSPECTING CUSTOMER INSTALLED METERS AND SERVICES**

WHEREAS, the District installs new services for new connections to the District’s distribution system including a service line from the water main to the meter and a new meter; and

WHEREAS, the District charges a fee to the new water customer to cover the District’s cost for the installation work and the fee varies based on the size (diameter) of the connection; and

WHEREAS, the District’s fee is based on a cost-of-service methodology for actual costs to the District including materials, equipment time, and labor; and


WHEREAS, the costs of materials, equipment time and labor increase over time, the Board of Commissioners finds that it is necessary to adopt amendments to the District’s new service installation and inspection fees in accordance with the Exhibit “A” - Schedule of Rates set forth below.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE WEST SLOPE WATER DISTRICT AS FOLLOWS:**


Section 1: Effective April 1, 2022 - The rates and charges shown in Exhibit “A” – Schedule of Rates attached hereto and by this reference incorporated herein, shall be adopted by the District.

**OTHER SERVICE CHARGES AND PENALTIES**

1. Turning on water by Water District personnel:
  - a. With an approved Turn On order from office staff during regular office hours No Charge
  - b. After office hours, weekends, and holidays No Charge
2. Special Service: Shut Off and/or Turn On at customer's/owner's request:
  - a. During regular office hours No Charge
  - b. After office hours, weekends, and holidays No Charge
3. Shutting Off and Turning On service for water non-payment:
  - a. During regular office hours \$100.00
4. Additional charges, if necessary, to enforce payment of a bill and/or charges:
  - a. Removal of the water meter \$25.00
  - b. Reinstallation of the meter No Charge
  - c. Turning on water after hours weekends or holidays \$200.00
  - d. Turning on and/or using water without authority from The District \$25.00
  - e. Installation or removal of a lock on a meter \$25.00
  - f. Repair of any breakage/damage to locking mechanism (curb stops, etc.) Parts & Labor + 15%
  - g. Shutting off water at the main or reinstating service Parts & Labor + 15%
  - h. Check returned by bank for non-payment (NSF) \$25.00
  - i. Electronic fund transfer (NSF) \$25.00
  - j. Replacing destroyed locks \$25.00
  - k. Notice of Shut Off placed on doorknob \$15.00
5. Decreasing or increasing the size of the meter Parts & Labor + 15%
6. Increasing the size of the service from the main New Service Charge
7. Testing water meters at the customer's or owner's request:
  - a. Testing on premises (1-inch or smaller) No Charge
  - b. Removal of meter for testing (1-inch or smaller) No Charge

c. Testing of meters larger than 1-inch	No Charge
8. Usage of a meter key (must be within the District)	No Charge
9. Removal of a meter during construction (Considered as vandalism and/or illegal use of water)	Parts & Labor + 15%
10. Fire hydrant permit (Mandatory by rule to use a hydrant for others besides the District and the FD)	
a. Permit – Rate Code WH2	\$78.83
b. Special usage (consumption only)	\$5.73 per CCF
c. Penalty for unauthorized hydrant use	\$500.00
d. Penalty for using a non-approved, non-inspected filling tank	\$500.00
