A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE WEST SLOPE WATER DISTRICT ADJUSTING DISTRICT EMPLOYEE SALARY SCHEDULES

WHEREAS, a regular meeting open to the public was held by the Board of Commissioners of the West Slope Water District on March 16, 2016 to discuss adjusting the District Employee Salary Schedules for Fiscal Year 2016 – 2017, effective July 1, 2016, and

WHEREAS, in accordance with the District's Adopted Budget Calendar for Fiscal Year 2016 – 2017; and

WHEREAS, based upon the General Manager's recommendations and testimony considered by the Board at the regular meeting, the Board of Commissioners finds that:

(1) The District shall increase the FY 2016 – 2017 Salary Schedule equal to the change in the Official U.S. Dept. of Labor, Bureau of Labor Statistics, Consumer Price Index – All Urban Consumers (CPI-U), Portland-Salem OR-WA for the year 2015 in the amount of 1.2%, as published February 2016.

BE IT RESOLVED:

Section 1: The 2016- 2017 Salary Schedule in Exhibit "A", attached hereto and by this reference shall be increased in the amount of 1.2%, equal to the Official U.S. Dept. of Labor, Bureau of Labor Statistics, Consumer Price Index – All Urban Consumers (CPI-U), Portland-Salem OR-WA for the year 2015, as published February 2016, effective July 1, 2016.

Section 2: The General Manager has the authority and discretion to pay entry level employees 80-percent of the minimum salary schedule and employees with demonstrated skills and experience up to 10-percent over the maximum salary schedule with the approval by the Board of Commissioners.
