RESOLUTION NO. 03-2023

A RESOLUTION AMMENDING THE DISTRICT'S FEES FOR INSTALLING NEW SERVICE CONNECTIONS, INSTALLING NEW METERS, AND INSPECTING CUSTOMER INSTALLED METERS AND SERVICES

WHEREAS, the District installs new services for new connections to the District's distribution system including a service line from the water main to the meter and a new meter; and

WHEREAS, the District charges a fee to the new water customer to cover the District's cost for the installation work and the fee varies based on the size (diameter) of the connection; and

WHEREAS, the District's fee is based on a cost-of-service methodology for actual costs to the District including materials, equipment time, and labor; and

WHEREAS, the costs of materials, equipment time and labor increase over time, the Board of Commissioners finds that it is necessary to adopt amendments to the District's new service installation and inspection fees in accordance with the Exhibit "A" - Schedule of Rates set forth below.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE WEST SLOPE WATER DISTRICT AS FOLLOWS:

<u>Section 1</u>: Effective April 1, 2023 - The rates and charges shown in Exhibit "A" – Schedule of Rates attached hereto and by this reference incorporated herein, shall be adopted by the District.
