1.0 - CALL TO ORDER

Chair Rieck called to order the special meeting of the West Slope Water District Board of Commissioners at 8:01 AM, Wednesday, October 18, 2017.

- Interview for Robert Peltz began at 9:51 AM with introductions around the panel followed by questions from the interview panel. The interview concluded at 10:15 AM,

and Mr. Peltz left the interview. The meeting recessed while each Board member scored the questions silently. The meeting resumed to begin discussion and a comparison of the scores for each panel member. The discussion and scoring comparison concluded at 10:35 AM.

The General Manager informed the Board Mr. Lance Clifford wished to have his name removed from consideration for the vacant Board position. The Board would be interviewing two candidates on Thursday: Susan Meander and John Ryan.
